Effective Strategies for Reducing Your Carbon Footprint: A Comprehensive Guide

Businesses and offices use a significant amount of gas and electricity for heating and cooling, lighting and operating equipment's. Here are a number of easy ways to reduce GHGs emissions, protect the environment, fight climate change, make the air cleaner and build positive image of your company, business house, office or campus.

Manage your office equipment energy use better. Total electricity consumed by idle electronics in the offices of the USA equals the annual output of 12 power plants. Save energy and reduce GHGs emissions at your offices in the following ways:

- 1. Setting your computer, monitor and other office equipments to power down or in a sleep or power saving mode when not in use,
- Activate the power management features on your computer and monitor,
- 3. Unplug laptop, personal computer, iPad or printer power cords when not in use,
- 4. Turn off equipments and lights at the

end of the day before leaving your work place,

5. Plugging everything into a power strip makes it easy to shut everything down at one time

Use less energy for your staff commute. For less carbon footprint in your organization's staff commuting the following measures be taken:

- 1. Switching to public transportation.
- 2. Arrange carpooling. A shared car is considered to equivalent to approximately 17 personal vehicles in terms of road area usage and carbon footprint.
- 3. Encourage staff for using biking.
- 4. Grant small or zero interest loan to your employees for buying bikes.
- 5. Provide cash incentives to your employees for green commuting.
- 6. Telecommuting can save energy and reduce GHGs emissions on your way to and from work.

- 7. Encourage your employer to offer commuter benefits that address limited or expensive parking, reduce traffic congestion.
- 8. Improve employee recruiting and retention and minimize the environmental impacts associated with drive-alone commuting.
- 9. For your transport pool, find out the fuel efficiency of your vehicles. You can have a look at the 'Federal Fuel Economy' website, and make more environmentally informed choices when purchasing your next vehicle by using EPA's 'Green Vehicle Guide'
- Go with paperless in your office. Try to do official correspondence without using paper. This attempt will save your money as well as lower your organizational carbon footprint. Some of the tips are given below:
- 1. Start electronic attendance of your employees.
- 2. Avoid hard copy letters with the employees, other stakeholders and with horizontal and vertical offices.
- 3. Make compulsory for all of your executives to open and check their official e-mails.
- 4. Serve official notice on website of your organization or through e-mail or through messaging over phones.
- 5. Choose e-tendering method instead of conventional bidding process.
- 6. Make the personal computers of your office local area network (LAN) connected.
- 7. Make arrangement for electronic file sharing.

Local governments can harvest rain water from roof tops. Municipality water tanks can store rain water as an alternative source of drinking water so that water supplying agencies are not solely reliant on ground water. Extracting ground water needs huge energy resulting to have larger amount of carbon footprint.

Have an online and sustainable university campus. This will reduce thousands of ton papers every month. This happens really in the advanced countries' higher educational institutes. Following initiatives may be taken in this regard:

- 1. Enroll your students through online admission process.
- 2. Ask your students to use online study materials.
- 3. Teachers will post various notices, class notes, hand-outs, power point presentations on the university website where the enrolled students have access.
- 4. Students will have to submit their assignments, essays, homework, research papers to their respective teachers through university e-mail.
- 5. Evaluation process will have to be done on soft copy scripts.
- Integrate sustainability into curriculum by providing minors in sustainability for all disciplines.
- 7. Embed sustainability into the university's governance and to fully engage diverse campus members.
- 8. To oversee the issues of reduction of carbon footprint establish a sustainability office in your university

with a sustainability team headed by a Chief Sustainability Officer.

10. Have patronage to run the student groups who work for sustainability enhancing.

Reducing, reusing, and recycling. At the office reduce, reuse, and recycle help conserve energy, and reduces pollution and GHGs emissions. Creating recycled paper save 55% water as compared to producing virgin paper. An amount of 65% less energy is required to make recycled paper in comparison to producing paper from virgin pulp. Followings are the some doables:

- 1. Set up your word programme default to have narrow margins. If more text fits on each page, you will end up saving paper over time when printing these documents.
- 2. Use printers and photocopiers that provide two-sided printing and copying.
- 3. Ask your office staff and executives to only printing what is not unavoidable.
- 4. Buying supplies made with recycled content; and recycling paper products, batteries, and used printer cartridges. All of these actions help conserve energy and reduce carbon pollution.
- 5. For old electronics e.g. computers, monitors, printers, cell phones, TVs etc. Investigate leasing programmes, manufacturer and retailer take-back programmes, and municipal programmes and events to ensure reuse and recycling.
- 6. You can also donate used equipment to schools or other organizations and take advantage of any available tax incentives for computer donations. For further information you may visit www.epa.gov/wastewise/website on

starting a recycling programmer at your office or industry or business.

Use Green Power. Emissions from electricity generated from fossil fuels can be one of the most significant environmental impacts associated with your organization's operations. Green power is electricity that is generated from renewable energy sources such as water flow wind, sun, geothermal, and biomass. Purchasing green power is an easy, effective way for your organization to reduce its carbon footprint and environmental impact. There are a number of steps you can take to create a greener office, including installing solar panels and researching incentives for renewable energy in your city or state.

Develop a GHGs inventory for your office or organization. Developing a GHGs inventory is a critical first step toward measuring and managing your organization's climate change impact. An inventory is a list of emission sources the associated emissions and quantified using standardized methods. Many organizations are taking this step and by doing so find that most of their emissions come from building heating and cooling, fleet vehicles, electricity use, and employee travel. EPA's Center for Corporate Climate Leadership in the USA is a resource center to help all organizations identify and achieve cost-effective GHG emission reductions.

Take off unwanted your name catalogue and newspaper subscriptions. U.S. catalogue production uses 53 million trees and 81,000 enough fill water to Olympic-sized swimming pools each year. In addition, Americans waste about 8 hrs per year dealing with junk. A huge amount of wastages of resources and time! 'Catalogue Choice in the USA is a free service that allows you to decide what gets in your office mailbox.

Use it to reduce mailbox clutter while helping save natural resources. You can still get your daily news fix by reading newspapers online.

Get a plant for your desk. Indoor plants act as filters that suck up all the pollutants created by your computer equipment while also cooling the air in your office. Plants cool air through a process called transpiration that transfers water from plants into the atmosphere. This allows them to act as a natural air conditioner, keeping the office a little cooler during the warm summer days. As extra dividend, your room will have a better look!

Look for **ENERGY** STAR-qualified products for the office. Office products that have earned the ENERGY STAR feature special energy efficient designs, which enable them to use less energy while performing regular tasks. Look for **ENERGY** STAR-qualified equipment, such as computers, copiers and printers, in addition to more than 60 product categories, including lighting, heating and cooling equipment, and commercial appliances.

Ask your office building manager make sure your building has earned the **ENERGY STAR labeled building.** ENERGY STAR-labeled buildings provide safe, healthy, and productive environments that use about 35% less energy than average buildings. Their efficient use of energy also reduces the operational cost of the building. Let your facility's maintenance department know about the ENERGY STAR buildings programme, so they can learn how to improve your building's performance.

Have a green committee in your office or organization. Work with your executives and colleagues and make them interested to practice green. Form a green committee with the enthusiastic and environment background people, Provide them with a minimum amount

of budget. Ask the committee to arrange small scale meeting or workshop or seminar for disseminating tips of reducing less carbon footprinting in company or other activities.

Greening vehicle your use. Organizations and offices are the users of large quantity of vehicles. Driving your vehicle pool releases GHGs into the atmosphere and contributes to climate change- but you can take simple, easy steps to cut your emissions, reduce our nation's dependence on oil, and save money. Following are the some important tips:

1. Buy smart: Purchase a fuel-efficient, low-GHG vehicle

When procuring a new or used vehicle or even renting a vehicle for your office, choose the cleanest, most fuel-efficient vehicle that meets your needs. With a wide range of clean, fuel efficient vehicles available today, it is easier than ever to go green-for the environment, and for your wallet. For example in the USA, check out 'EPA's 'Green Vehicle Guide' or www.fueleconomy.gov to find the best, most comprehensive information on vehicle emissions and fuel economy.

2. Gasoline vehicle label

You can also learn more about the fuel economy and environment label that you will see on all new vehicles. The label has been redesigned and updated for even easier comparison shopping. These new window stickers provide fuel economy and environmental ratings for all new vehicles, including advanced technology vehicles like electric cars and plug-in hybrids. And while at the showroom, you can scan the QR Code® on each vehicle's label to be connected additional information online. including personalized and cost

energy-use estimates.

3. Drive smart

To improve your fuel economy and reduce GHGs gas emissions, go easy on the brakes and gas pedal, avoid hard accelerations, reduce your time spent idling (no more than 30 seconds), and unload unnecessary items in your trunk to reduce weight. If you have a removable roof rack and you are not using it, take it off to improve your fuel economy. Use cruise control if you have it, and for vehicles with selectable four-wheel drive, consider operating in two-wheel drive mode when road conditions make it safe to do so.

4. Remember maintenance.

Get regular tune-ups, follow the manufacturer's maintenance schedule (which can be found in your owner's manual), and use the recommended grade of motor oil. A well-maintained car is more fuel-efficient, produces fewer GHGs gas emissions, is more reliable, and is safer! 5. Have care for your tires!

Check your tire pressure regularly. Under-inflation increases tire wear, reduces your fuel economy, and leads to higher GHGs and other air pollutant emissions. If you do not know the correct tire pressure for your vehicle, you can find it listed on the door to your vehicle's glove compartment, or on the driver's-side door pillar. And when it's time for new tires, consider purchasing tires with "low rolling resistance," an energy-saving feature.

6. Give your carpool a break

Encourage your employees to use

public transportation, carpool, or walk or bike whenever possible to avoid using company or official vehicle. Compelling your employees' cars be at home just two days a week can reduce GHGs emissions by an average of two tons per year. Also consider telecommuting i.e. working from home via phone or the internet, which can reduce the stress of commuting, reduce harmful emissions.

7. Use renewable fuels

Give E85 and biodiesel a try. Both are renewable fuels made from renewable sources such as corn that can reduce GHGs emissions from your vehicle. E85 is a fuel blend containing 85% ethanol and 15% gasoline that can be used in certain vehicles called Flex Fuel Vehicles (FFVs) FFVs are designed to be fueled with either E85 or traditional gasoline. There are millions of FFVs on the road today in the USA -to find out if you own one, check the inside of your car's fuel door for an identification sticker, or consult your owner's manual. If you own a diesel vehicle, consider filling up with a biodiesel blend such as B5, which is a diesel fuel blend containing 5% biodiesel In the USA, the Department of 'Energy's Alternative Fueling Station Locator can help you locate both E85 and biodiesel fuel stations in your area.

Employees and staff do not live at offices or company or factory houses. Although some days it feels like some of them do. They can still do their part at work to be as environmentally minded and calculative as they are at home. If everyone at your workplace, company, office or campus adopts at least one of these tips it can lead to big differences for our environment as well as the organizations' pocket book.





The ADB Consultation Mission team met with Public Private Partnership Authority's Chief Executive Officer (Secretary) Mr. Muhammad Rafiqul Islam at the PPPA office to discuss PPP structuring approach, procurement strategy and alignment with the national PPP framework—advancing sustainable development through strategic collaboration.

Report on the 7th Bangladesh-Japan Joint Public-Private Partnership (PPP) Platform Meeting

In a bid to facilitate the implementation of PPP projects under the joint initiative of Bangladesh and Japan, a Memorandum of Cooperation (MoC) was signed on June 15, 2017, between the PPP Authority of the Government of Bangladesh and Japan's Ministry of Land, Infrastructure, Transport and Tourism (MLIT). According to the signed MoC, the Bangladesh–Japan Joint PPP Platform convenes annually. As part of this ongoing collaboration, the 6th Bangladesh–Japan Joint PPP Platform Meeting was held in Dhaka on March 18, 2024.

2. In continuation of this engagement, the 7th Bangladesh-Japan Joint PPP Platform Meeting was organized by the Government of Japan under the auspices of MLIT and took place in Tokyo from March 11 to March 13, 2025. 3. The first session of the 7th Bangladesh–Japan Joint PPP Platform Meeting was held on March 11, 2025, at the Mita Kaigaisho Conference Room in Tokyo, Japan. The session commenced with opening remarks delivered by Mr. Yosuke Tsutsumi, Assistant Vice Minister of MLIT, and Mr. Muhammad Rafiqul Islam, Chief Executive Officer (Secretary) of the Public Private Partnership Authority, on behalf of the Government of Bangladesh.

Following the inaugural addresses, representatives from the Government of Bangladesh and Japan's private sector investors, under the Sub Working Group (SWG), presented a PowerPoint overview highlighting the implementation progress of ongoing projects. These projects, listed below, were the focus of detailed presentations and in-depth discussions during the 7th Platform Meeting.

4. The second session of the meeting was held on the same day from 3:40 PM to 5:40 PM Japan Standard Time. The session commenced with opening remarks from Mr. Hirofumi Amakawa, Vice Minister of MLIT, on behalf of the Government of Japan, and Mr. M. Siraj Uddin Miah, Principal Secretary to the Chief Adviser, representing the Government of Bangladesh.

Additionally, H.E. SAIDA Shinich, Ambassador of Japan to Bangladesh, and H.E. Md. Daud Ali, Ambassador of Bangladesh to Japan, delivered brief remarks during the opening of the session.

Subsequently, a representative from Japan's MLIT presented a summary of the discussions held during the first session. This was followed by presentations from the Government of Bangladesh on proposed new projects. The details of the new project presentations are as follows:

Discussions were held on the presented projects by representatives from both governments and the Japanese private investors attending the session. Following this, the Government of Japan initiated a full scale discussion on the Potential Project List.

On 12th March 2025, under the management of MLIT, the delegation visited the Haneda Airport and Haneda Chronogate site, both established under the PPP modality.

On the final day, 13th March 2025, the delegation visited the Redevelopment project area of Takanawa Gateway under MLIT's management, followed by a visit to the Tokyo Station (Multimodal Hub) on the same day.

In addition to observing the main activities of the projects, the delegation gained a comprehensive understanding of the various citizen services, as well as the successful management of other commercial, tourism, and entertainment facilities, and the various benefits of the PPP projects.

The 3rd Meeting of the Board of Governors of the Public-Private Partnership (PPP) Authority held





Chief Adviser's Office

The 3rd meeting of the Board of Governors of the Public-Private Partnership (PPP) Authority was chaired by Dr. Muhammad Yunus, Hon'ble Chief Adviser of the Government of the Bangladesh. At the outset, Chairperson welcomed all attendees. The Principal Secretary to the Chief Adviser M. Siraz Uddin requested the Chief Executive Officer of the PPP Authority Mr. Muhammad Rafigul Islam to present the agenda items.

The Chief Executive Officer reported that the PPP pipeline currently includes 79 projects across various ministries, involving an estimated investment of USD 47.31 billion. Of these, 22 projects have signed agreements with private partners (USD 5.2 billion in investment), 4 are fully operational, 2 are partially operational, 7 are under and construction combined with estimated cost of USD 1.63 billion. A further 9 projects are advancing toward financial closure, while 30 projects are undergoing feasibility studies.

The Authority is also engaging in G2G

PPP partnerships with countries such as Japan, Singapore, Saudi Arabia, Denmark, Dubai, and South Korea, with several projects under implementation totalina billions in foreign direct investment. Notably, Sumitomo Corporation has been nominated by Japan for the Operation & Maintenance of Hazrat Shahjalal International Airport 3rd Terminal, now at the RFP stage. Concerns over the terminal's future management and ground handling responsibilities were discussed, with the formation of a review committee recommended.

The Kamalapur Multimodal Hub project, led by the Ministry of Railways, was also discussed in light of potential conflicts with DMTCL's MRT-6 station expansion. The private partner Kajima Corporation expressed concerns that the MRT jeopardize expansion hub may implementation. The Principal Secretary instructed a reassessment of the design area and directed Bangladesh Railway and the Road Transport and Highways Division to coordinate on resolving the issue.

The Special Envoy on International Affairs to the Chief Adviser updated the board on key G2G PPP projects under Chattogram Port Authority, including the New Mooring Container Terminal, Laldia Terminal, Bay Terminals 1 & 2, and Patenga Container Terminal, covering progress, actions, and timelines.

Key decisions taken in the meeting:

 A committee will be formed to evaluate and fast-track the implementation and management model for HSIA 3rd Terminal. 2. The Ministry of Railways and Road Transport and Highways Division will jointly address and resolve issues related to the Kamalapur Multimodal Hub project and report back to the Chief Adviser's Office.

The meeting was held on 13th April, 2025 at Chief Adviser's Office in Dhaka. It was attended by the members of Board of Governor's including Finance Adviser Dr. Salehuddin Ahmed.

The meeting concluded with appreciation for the active participation of the members and their constructive input.

Inauguration:

Ms. Kashfia Ahmed welcomed participants to the forum, emphasizing awareness raising on PPP for infrastructure development, stakeholder engagement, and identifying opportunities.

2. Special Guest's Address:

Deputy Commissioner of Chattogram Ms. Farida Khanom greeted attendees and encouraged participation in PPP initiatives for smart city systems, tourism infrastructure (e.g., Sandwip, Patenga), logistics and transport hubs, modern education and healthcare centers, and green sustainable urban development. She affirmed continued support from Chattogram District Administration.

3. Chief Guest's Address:

Mr. Muhammad Rafiqul Islam began by paying tribute to the martyrs of July-August's uprising, then provided an overview of PPP's establishment (2010) and highlighted plans to enhance PPP's momentum in Chattogram. He noted 81 ongoing PPP projects nationwide, including several in Chattogram, and emphasized PPP's role in infrastructure, employment generation, technology transfer, and capacity building. He reiterated the importance of stakeholder input and the need for an investment - friendly environment aligned with local needs.

4. Introduction of PPP Authority & Success Stories:

Mr. A.K.M. Abul Kalam Azad, Director General, delivered a presentation on PPP's type, scope, organizational structure, and achievements highlighting government private sector benefits in project execution.

5. Chief Guest's Presentation:

The Chief Executive Officer presented PPP Authority's vision, mission, strategic objectives, legal framework, and previous successes—detailing public—private collaboration mechanisms.

6. Chairperson's Remarks:

Dr. Md. Ziauddin thanked the Chief Executive Officer for attending and described Chattogram as Bangladesh's economic heart. He highlighted PPP's potential to attract local and international investment, praised the direct engagement of government with investors at the conference, and noted that PPP allows profit sharing beyond GOB projects. conventional He concluded with gratitude to the people of Chattogram.

7. Open Discussion Highlights:

Mr. Md. Aheduzzaman (KSRM Group HR Head): Asked whether long term PPP projects are resilient during political

crises, and if the Jatrabari Flyover is a PPP project.

Chief Executive Officer shared that no PPP project has been canceled due to political crises in Bangladesh; such resilience is expected to continue. The Jatrabari Flyover, however, is governed under a specific law, not PPP.

Mr. Nasir Uddin (Alhaj Shamsul Haque Foundation): Proposed using model mosques under the Islamic Foundation for funeral services (washing, shrouding, burial) through PPP.

Director General confirmed the feasibility of PPP for operations and maintenance and invited proposals through relevant ministries.

Chamber of Commerce Representative stressed the need for clear timelines and publication of unused government land on a portal to attract investment.

Director General supported the idea and committed to implementation.

Media Representative (Dainik Karnaphuli) asked whether PPP could improve healthcare standards in railway hospitals suffering from staff shortages.

Chief Executive Officer mentioned active PPP projects, including: Hemodialysis Centre at Chittagong Medical College Hospital (CMCH) & National Institute of Kidney Diseases & Urology (NIKDU), Shopping Mall with Hotel – cum – Guesthouse on Bangladesh Railway Iand near Chattogram Railway Station, Modernization of Railway Hospital at CRB in Chattogram.

Dr. Md. Ahsanul Haque (Forest Officer) asked about PPP opportunities for forest department involvement.

Mr. A.M. AI - Amin (PPP Monitoring & Procurement Advisor) noted that forest

carbon credits could be marketed under PPP.

The Daily Amar Desh Media Representative inquired about PPP with the Shamsul Haque Foundation for three railway hospitals.

Chief Executive Officer emphasized the need for PPP mindset versus GOB and highlighted other PPP hospital/institute projects already in motion, including; Medical College & Nursing Institute and modernization of Railway Hospitals in Kamlapur, Paksey (Pabna), Saidpur (Nilphamari), and a new 250 - bed hospital on unused land in Khulna.

Apart from here, few other paticipants attended in discussion. A question and answer session was also held.

8. Closing & Vote of Thanks:

The Chief Executive Officer thanked all participants for attending and reiterated PPP's status as a new concept, urging continued interest to foster investment-friendly, collaborative environment. He expressed hope that future generations will benefit from today's PPP efforts. The conference concluded with thanks to everyone Specially Chattogram District Administration for its success.

9. Key Recommendations:

 a) Consider incorporating "time bundles" in PPP project planning and implementation.

- b) Reaffirm that no PPP projects have been canceled due to political crises, and such safeguards will continue.
- c) Promote utility-linked PPP opportunities by facilitating land leases for investors.
- d) Publish lists of unused government land on the PPP Authority's web portal.
- e) Enable PPP proposals for funeral services at model mosques under the Ministry of Religious Affairs and Islamic Foundation.

1. Inaugural Session

Mr. Ali Azam Al Azad welcomed attendees the PPP Divisional to Conference, Barisal 2025. He noted that coastal Patuakhali can play a crucial role in Bangladesh's economic development. He emphasized that PPP is vital for growth, infrastructure stakeholder coordination, investment preparation, identifying viable project and opportunities. He expressed optimism for joint private public investment in the region's promising sectors.

2. Special Guest's Address

Deputy Commissioner of Patukakhali Mr. Abu Hasnat Mohammad Arefin greeted participants warmly. He highlighted Patuakhali's potential in agriculture and fisheries, and suggested PPP's usefulness in agro-processing, modern fish farming, and export capacity building. He also

mentioned that expanding sunflower cultivation for edible oil through PPP could reduce national dependency on oil imports. He pointed out opportunities in sugarcane-based industries via PPP, which could strengthen the district's economy.

3. Chairperson's Remarks

Divisional Commissioner Mr. Md. Raihan Kawsar welcomed evervone thanked the CEO of PPP Authority. He noted that PPP is timely and crucial for development in a growing country like Bangladesh and is already successful in neighboring nations. He highlighted Barisal's industrial potential, noting that around 55% of the country's mung bean is produced in the Barisal division, with Patuakhali contributing significantly. He underscored the scope agro-based industries. He expressed confidence that participants would gain practical insights into PPP from the event, benefiting both national development and individual capacity building.

4. Guest Speaker's Presentation

Dr. Mahmudur Rahman (Deputy Project Director, Dhaka Elevated Expressway) spoke about the Dhaka Elevated Expressway. He described it as one of the country's largest PPP projects, a successful joint investment between government and private sectors. It has helped reduce traffic congestion in the capital, saving travel time and fuel. He commended its economic impact and eco-friendly technology, and suggested it as a model for future PPP projects.

5. Chief Presenter's Presentation

Chief Guest Mr. Muhammad Rafiqul Islam delivered a presentation on PPP Authority's vision, mission, strategic objectives, role, concept, definitions, legal framework, and successes. He also discussed project implementation processes, preospective PPP prjects in Patuakhali investment strategies, and mechanisms for private-sector engagement aimed at sustainable development.

6. Introduction to PPP Authority & Success Stories

Mr. A.K.M. Abul Kalam Azad, Director General of PPP Authority, presented "PPP Authority and Its Success Stories." He covered the fundamental concepts, scope, organizational structure, and achievements of the PPP model. He illustrated how PPP leverages government and private resources to implement infrastructure and public service projects, discussed investment prospects, and highlighted future plans.

7. Chief Guest's Address

Mr. Muhammad Rafiqul Islam expressed areetings and participants. He noted PPP Authority was established in 2010 and has since promoted infrastructure development and service sector investment through public-private partnerships. He emphasized Patuakhali's potential in agriculture, tourism, renewable energy, and light industry and encouraged a more dynamic PPP approach to tap these. He reiterated PPP's role employment generation, technology transfer, and skills development. He added that PPP Authority currently oversees 81 projects, including several in Barisal division. He emphasized aligning with local needs and projects environment and stressed importance of stakeholder input. He concluded by expressing gratitude to all attendees.

8. Open Discussion

A prominent businessman from Barisal asked if small - scale PPP projects have a minimum investment threshold. CEO noted the 2015 PPP Act specifies no minimum investment amount. Responded that "Small PPP Guidelines" are being developed to encourage SME participation and expand local project implementation.

A public representative proposed enabling joint investment for small PPPs through shareholding and recommended classifying procedural steps (large, medium, small) on the PPP Authority website. CEO Appreciated the suggestion and assured the website would include these classifications to facilitate investor decision- making.

Another delegate asked about typical Return on Investment (ROI). Mr. A.M. AI -Amin: Explained ROI varies by project, but generally it ranges between 13% and 15% per annum in Bangladesh. A business representative noted the need modernize Patuakhali's 250bed hospital. He emphasized long-standing gaps quality healthcare. in confirmed that high quality dialysis services are already being provided via PPP at National Institute of Kidney Diseases and Urology (NIKDU) and Chattogram Medical College Hospital, and encouraged investment by Barisal entrepreneurs in similar projects.

Another businessman mentioned numerous unused lands in Patuakhali and asked if government is taking action. CEO clarified PPP projects can be launched on both public and private lands, and said investors would receive incentives for renewable energy projects via PPP.

9. Closing & Vote of Thanks

The CEO thanked all attendees specially Patuakhali District Administration and stated that PPP opens new horizons for Barisal and the country. He urged creating a skilled, conscious, partnership oriented, investment friendly environment. He expressed hope that future generations would benefit from these initiatives and called on officials and entrepreneurs to pursue renewable energy PPP projects. The conference concluded with a vote of thanks.

10. Key Recommendations

- a) Rapidly establish and implement "Small PPP Guidelines" to encourage SME participation and local PPP project implementation.
- b) Categorize processes by project scale (large, medium, small) and publish on PPP Authority's website to help investors select suitable projects.
- c) Promote joint participation by small investors through consortium based PPPs.
- d) Launch PPP projects to modernize hospitals and healthcare services in Patuakhali to enhance quality of care.
- e) Activate unused public and private land in Kolapara area for PPP projects, especially in renewable energy.

11. Site Visit

After the conference, investors visited unused lands belonging to BCPCL, RPCL, and APSCL. Many expressed interests in developing PPP projects on these sites.

Inauguration:

The conference began with a welcome note by the moderator, Ms. Kashfia Ahmed, who outlined the objective of raising awareness of the PPP model among public-private stakeholders, identifying development potential, and highlighting the significance of PPP in infrastructure development.

2. Welcome Speech by the Deputy Commissioner:

Ms. Hosna Afroza expressed gratitude for selecting Bogura as the venue and mentioned its long-standing neglect. She highlighted ongoing initiatives like establishing a public university and airport revival. She urged investors to explore PPP opportunities in smart city management, tourism infrastructure, logistics and transport hubs, modern

healthcare and education, and green urban development. She assured full support from the District Administration for PPP projects.

3. Chief Guest's Address:

Mr. Muhammad Rafiqul Islam welcomed participants and emphasized the need to expand the PPP model in Rajshahi and Rangpur to unlock untapped potential. He stated that the PPP Authority is working on 82 projects nationwide, with several in the Rajshahi region. He highlighted the Authority's focus on utilizing unused government assets, encouraging private sector participation, and incorporating local needs into project design.

4. Presentation:

Introduction of PPP Authority & Success Stories:

Mr. A.K.M. Abul Kalam Azad, Director General, presented the organizational structure, operational scope, and achievements of the PPP Authority, highlighting public and private benefits from successful PPP implementation.

5. Keynote Presentation by the Chief Guest:

The Chief Executive Officer elaborated on PPP Authority's vision, mission, strategic objectives, and the legal framework. He emphasized the potential for project expansion in Rajshahi and Rangpur and outlined the structure enabling both public and private collaboration.

6. Remarks by Special Guest:

Mr. Parvez Raihan, Director of Local Government, termed Rajshahi an emerging economic zone and strongly advocated for the PPP model. He called PPP a transparent and profitable system for private investors and a solution for government resource constraints. He appreciated the relevance of the conference and its role in bridging public-private goals.

7. PPP Monitoring & Procurement Advisor's Remarks:

Mr. Md. A.M. Al-Amin presented a detailed process of PPP project procurement and identification of opportunities in the Bogura region, encouraging investors to come forward.

8. Presentation by BTMC's PPP Project Director:

The Director shared the legal security and procurement guidelines under PPP. He assured investors of reliability and encouraged them to invest in confidence. He also presented the success story of the Rajshahi Textile Mills PPP project.

9. Panel Discussion and Q & A Highlights:

Mr. Md. Ekramul Sarker raised the issue of potato overproduction in Bogura and lack of cold storage facilities. The CEO confirmed that a similar unsolicited project proposal had been submitted through the Ministry of Agriculture, and the revised version is under review.

Mr. A.K.M. Mahfuzur Rahman inquired about investor profit-sharing, co-investment models, and risks due to potential government changes.

Mr. Iftekhar Ahmed of Bengal Group proposed utilizing unused government land to establish a nursing institute. The Director General responded that such PPP projects are already underway and new proposals are welcome.

Rajshahi Chamber of Commerce's Executive Director suggested including details of unused lands on a web portal to facilitate investment. The DG welcomed the proposal for implementation.

Forest Officer Mr. Md. Ahsanul Haque discussed integrating the forest department into PPP models for conservation and infrastructure synergy. All queries from government and private representatives were addressed during the session.

10. Closing Remarks:

The Chief Executive Officer of PPP Authority, Mr. Muhammad Rafiqul Islam, thanked all guests and participants for their contributions. He emphasized that PPP is a new but essential concept for Bangladesh and called for inclusive, investment-friendly environments. He urged private investors to explore PPP projects on unused government lands specially of sugarmills in the north and expressed hope that future generations will benefit from today's PPP initiatives.

11. Key Recommendations from the Workshop:

- a) Promote cold storage and agri-supply chain projects in northern Bangladesh under the PPP model.
- b) Reassure investors of PPP project stability regardless of political changes, backed by legal and procurement guidelines.
- c) Compile and publish a list of unused lands under ministries and departments on the PPP Authority's web portal.
- d) Establish a PPP support desk at the DC office for private sector assistance.
- e) Propose renewable energy projects on unused sugar mill lands through Bangladesh Sugar Mill Corporation.
- f) Encourage submission of PPP proposals for seed production on unused sugar mill lands.
- g) Call for project proposals for

Bogura and Ishwardi airport infrastructure development and operations under PPP.

11.8 Engage the Directorate General of Health Services/Bogura Civil Surgeon in developing healthcare PPP projects.

12. Participants:

42 government officials, 5 media representatives, 5 private organization representatives, and 47 investors and entrepreneurs from Rajshahi and Rangpur Divisions participated in this workshop and conference.

Project Overview:

The "Construction of Dhaka Outer Ring Road through PPP" project, under the Roads and Highways Department, received in-principle approval from the Cabinet Committee on Economic Affairs (CCEA) on 25 September 2019. As per a G2G (PPP) model, a Memorandum of Un-

derstanding (MoU) was signed between the Governments of Bangladesh and Japan on 15 June 2017 for implementing the project.

According to the MoU, the 52.215 km long expressway will be constructed in the following three segments:

- 1. Hemayetpur to Kalakandi 20.450 km
- Kalakandi to 3rd Shitalakhya Bridge 19.545 km
- 3. 3rd Shitalakhya Bridge to Madanpur 12.220 km

The project will form a ring expressway surrounding Dhaka city, which will play a vital role in easing traffic congestion in the capital.

Summary of Field Visit:

future plans.

To inspect the proposed alignment of the "Construction of Dhaka Outer Ring Road through PPP" project, the joint delegation of Bangladesh and Japan commenced their journey from the PPP Authority office, Agargaon, Dhaka at 10:00 AM on 17 June 2025. At 11:30 AM, the team started for the Dhaleshwari Toll Plaza and arrived there at 12:20 PM. Subsequently, the delegation visited several key sites along the proposed expressway alignment. During the visit, extensive discussions were held on project progress, structural development, potential challenges and

As part of the visit, the team first reached the Dhaleshwari Toll Plaza situated at the endpoint of Route-1 (Dhaka-Bhanga-Nimtoli Kalakandi Expressway) and the starting point of Route-2. A brief stakeholder consultation with meeting was held there, participation from PPP Authority, Road Transport and Highways Division, Roads and **Highways** Department and Japanese ministry and agency representatives. The discussion focused project potential, engineering on challenges and investment structure. Thereafter, the delegation proceeded through Sirajdikhan, Munshiganj to the endpoint of Route-2 and starting point of Route-3. They reached the roundabout near Shitalakhya Bridge where they had

lunch at the toll plaza rest house and discussed project-related matters in detail. Finally, the team visited Madanpur, the endpoint of Route-3 and reviewed the overall progress of the project area.

Key Recommendations from the Field Visit:

- Ensure regular monitoring of each phase of the project;
- 2. Enhance coordination among the Road Transport and Highways Division, MLIT, PPP Authority, Roads and Highways Department and foreign investors;
- 3. Expedite the land acquisition process at the local level;
- 4. Take proactive measures to mitigate environmental impacts of the project;
- 5. Provide necessary policy and administrative support to implement the project on time.

offered This field visit clear a understanding of the current progress and future direction of the Construction of Dhaka Outer Ring Road project. The joint cooperation between Japan and Bangladesh is expected to accelerate successful project delivery. The project is anticipated to become a milestone in Bangladesh's infrastructure development.

The Chief Executive Officer (Secretary) of the PPP Authority extended sincere thanks to all visiting foreign delegates, representatives of concerned agencies and officials. He urged all stakeholders to work in an integrated manner for the successful implementation of the project. 

Introduction

As Bangladesh moves ahead with heightened ambitions, a key issue the nation confronts is how to maintain economic growth while lessening reliance on external loans. The requirements for infrastructure immense - including roads, bridges, hospitals, and modern utilities - and fulfilling these needs solely through traditional public financing impose a significant debt load on the government. In this scenario, (PPP) Public-Private Partnership surfaces as a timely and strategic approach to finance development, enhance capabilities, and alleviate the burden of foreign borrowing on the national economy.

PPP: A more Intelligent Option than foreign loans

Historically, Bangladesh has heavily depended on concessional loans and development aid from both bilateral and multilateral sources. Although these funds have facilitated numerous large projects, increasing debt repayments, interest costs, and currency depreciation issues have raised worries about long-term fiscal health.

Public-Private Partnerships (PPP) enable the government to draw in private investment — from both local and international sources — into essential sectors without increasing public debt. Rather than taking out loans, the government collaborates with private partners in sharing the project's responsibilities, risks, and benefits. This approach allows for the efficient delivery of vital infrastructure and services without accruing additional external liabilities.

Important domains in which PPP can quicken prosperity and lessen loan dependency

1. Infrastructure without debt

Under PPP models, private partners finance projects such as power plants, highways, airports, and container terminals. They recoup expenses through long-term leasing agreements, tolls, or user fees. This keeps government borrowing low while still achieving development targets.

Examples like the Dhaka Elevated Expressway or Purbachal Expressway demonstrate how mega projects can move forward under PPP, attracting foreign investment and creating local employment — all while avoiding loans that would otherwise burden public coffers.

2. Efficient public services through private innovation

PPP may bring efficiency, accountability, and innovation to public services, from smart water management to ICT-based services and medical diagnostics in public hospitals. The government can provide better results at lower prices when private operators participate in and run these services under performance-based contracts, which again lessens the need for expansion funded by debt.

3. Industrial zones and economic hubs

PPP plays a crucial role in establishing economic zones, ports, logistics parks, and agro-processing centers. These generate employment, investments draw in businesses focused on exports, and enhance tax income. Rather than borrowed money on infrastructure projects, the government can lease land, provide policy backing, and allow the private sector to spearhead capital investment-alleviating financial the burden on the public sector.

Easing fiscal strain, boosting economic assurance

PPP diminishes the reliance on foreign simultaneously borrowing while fostering confidence among investors prolonged regarding Bangladesh's economic stability. Effective PPPs illustrate that Bangladesh is a nation capable of accommodating significant investments in a manner that is transparent, profitable, and sustainable leading to the gradual influx of more private capital.

Furthermore, reduced reliance on external debt enhances the nation's credit reputation, bolsters the taka, and generates fiscal flexibility to allocate resources towards social sectors such as education and health, where private investment is often constrained.

Role of PPP authority: building a bridge between government and business

Bangladesh's PPP Authority, which operates under the Prime Minister's Office or Chief Adviser's Office, is crucial in the planning, endorsement, and facilitation of PPP initiatives. By providing definitive guidelines, legal structures, and assistance in project development, the Authority guarantees that collaborations are equitable, financially viable, and advantageous for the public.

Additionally, it safeguards public interests through mechanisms for risk-sharing, assessments of value for money, and ongoing contract supervision—vital measures to avert project failures and maintain the affordability and accessibility of services.

Conclusion: PPP as a means to autonomous development to foster a thriving Bangladesh, investment essential - but without accumulating excessive foreign debt. PPP offers a clever, sustainable, and inclusive where strategy for progress, development is fueled not through significant borrowing, but by attracting investment, fostering innovation, and enhancing efficiency within the private sector.

By expanding effective PPP projects throughout various sectors and regions, Bangladesh can alleviate the pressure of external loans, empower local entrepreneurs, and establish resilient, future-oriented infrastructure — thereby creating a foundation for a self-sustaining economy.

Access to public services, encompassing vital provisions such as education, healthcare, water sanitation, and infrastructure, constitutes a cornerstone of inclusive growth. Indeed, the equitable delivery of these services, irrespective socioeconomic status, serves to improve the quality of life for all. Facilitating improved access necessitates not only an increase in service availability for citizens but also the enhancement of affordability, the fostering of innovation. and assurance of user-friendliness. Public-Private Partnerships (PPPs) have become a significant mechanism for enhancing access to these essential public particularly services, developing economies struggling with public sector capacity and resource limitations. This indeed provides a broad indication of how PPPs perform their tasks, which requires greater specificity.

The capacity of PPPs to enhance access public services and generate economic opportunities for marginalized populations is well-established. Nevertheless, the realization of this capacity necessitates careful consideration of several key determinants, including infrastructure

coverage and accessibility, contractual relationships and partner satisfaction, the affordability of service provision, service quality (in terms timeliness), cost-effectiveness and frameworks, pro-poor policy environmental concern in service delivery, community participation, and stakeholder engagement. elements are critical for both improving services public promoting inclusive growth. It is now important to examine how far these inclusivity dimensions are perceived in Bangladesh's PPPs.

The Government of Bangladesh enacted the Bangladesh Public-Private Partnership Act, 2015, establishing a regulatory framework intended facilitate private sector involvement in the provision of public services. This Act also aims to address the fundamental needs of the people of Bangladesh, expedite socio-economic advancement, elevate living and standards. Within this current regulatory framework, twelve of the seventy-eight projects in the pipeline are either fully operational, partially operational, or at the stage of construction. With respect to those projects that are fully or partially operational presented

Table-1, it is of critical importance to ascertain whether they are effectively meeting the basic needs of the citizen

through the enhancement of access to public services.

This article examines the role played by PPPs in enhancing access to service delivery across diverse sectors. including Road, Port, Health, Water, and ICT. This examination is done based on perceptions stakeholders' determinants. aforementioned key These determinants encompass infrastructure coverage accessibility, contractual relationships and satisfaction among partners, the affordability of the service, the efficiency of service delivery with respect to cost, the efficiency of service delivery with timeliness, respect environmental considerations pertaining to service delivery.

In order to examine perceptions regarding access to public services within operational and partially operational PPP arrangements, a

questionnaire survey was administered via Google Forms. The respondent pool comprised PPP implementing officials from both the public and private domains, officials from line ministries, representatives of the PPP Authority, and subject matter experts. Participants were purposively selected based upon their demonstrated competence in PPPs and their comprehension of the specific projects under investigation. The survey findings presented in Figure-1 reveals heterogeneous perceptions various PPP performance across projects in the domain of access to public service delivery. The presented as average scores wherein higher values denote more favorable perceptions, indicates positive a assessment by respondents in terms of access to public services.




Figure-1: Perception of stakeholders in improving access to public service

The Health sector PPP demonstrates the most robust overall perceived performance with regard to access to public services, registering an average score of 78%. Favorable perceptions

were observed in the areas of infrastructure coverage and accessibility, affordability, and environmental concerns, suggesting a perceived effectiveness of these PPPs in

addressing pertinent community needs. Road sector PPPs also exhibit a relatively strong performance in facilitating access to public services, attaining an average score of 76%, with infrastructure accessibility coverage and contractual relationships identified as areas of particular strength. Water sector PPPs reflect this similar overall performance, achieving an average score of 76%, with notable strengths in contractual relationships and environmental concerns.

While Port PPPs are generally perceived favorably with respect to access to public services (average score of 72%), performance perceived infrastructure coverage, accessibility, and affordability is comparatively lower than that of health, road and water sectors. However, the most notable divergence is evident in the ICT PPP sector. Despite an average score of 60% for access to public services, indicating a less positive overall perception, the most significant area of weakness pertains to contractual relationships and partner satisfaction. This finding stands in contrast to the theoretical expectation of enhanced access to public services through ICT Consequently, this suggests potential challenges in the formulation and management of ICT PPP contracts, potentially impacting both service delivery efficacy and stakeholder satisfaction. Furthermore, affordability, cost efficiency, timing efficiency, and environmental considerations are also identified as areas requiring enhancement within ICT PPPs.

The projects examined herein represent substantial milestones in the nation's trajectory of investment and growth, realized through advancements infrastructure and the establishment of service delivery mechanisms employing PPP route. These initiatives are truly found aligned with meeting salient policy objectives, provision health services of vulnerable populations, the extension of ICT services to rural communities (thereby mitigating the digital divide), the provision of port facilities to the business sector (facilitating logistical transformation), the provision of water supply and sanitation services to new inhabitants of the Purbachal area, and the alleviation of traffic congestion for commuters within Dhaka city.

In summary, based upon the empirical data, it may be concluded that all projects under scrutiny demonstrate a noteworthy enhancement of access to public services and function important drivers of inclusive growth. However, a definitive assessment of their long-term robustness or potential insignificance remains premature, given that the majority of the projects have only recently commenced operational phases following the full or partial construction. completion of Furthermore, the heterogeneity project scale and sector presents challenges direct comparative for analysis. Finally, the findings of this study hiahliaht the need for judicious interventions in contractual frameworks, with the potential to enhance access to service dimensions.

This convergence requires alignment not only on project goals but also on public perception. Key Communication Strategies for PPP Success

Digital dashboards, public briefings, infographics and open Q&A forums are simple yet powerful tools for keeping communication two-way.

3. Bring People Into the Process

Successful PPPs listen-not iust announce. Community consultations, local language messaging and active dialogue help ensure that impacted communities feel included, sidelined. In projects with strong public interaction-like urban renewal housing-emotional connection is as vital as technical precision.

4. Be Ready for Challenges

Even the best-planned projects face hurdles. When delays, land issues or environmental concerns arise, proactive communication can prevent crisis from turning into backlash. A trained spokesperson, timely updates and an honest tone help maintain credibility.

5. Brand Each Project with Purpose

Think of each PPP as a brand—with its own identity, value and reputation. Naming projects, using consistent visuals, sharing human-interest stories, and creating a digital footprint make PPPs more relatable to the public and more attractive to investors.

A Path Forward: A National Communication Framework

To streamline efforts, PPPA may consider a National PPP Communication Framework, offering:

- Standard templates for project communication
- Branding guidelines for PPP identity
- Digital and social media strategies
- Crisis communication protocols
- Capacity building for officials and partners

Such a framework would ensure that every project speaks with one voice-confident, transparent and people-first.

Trust Is Infrastructure

PPPs are not just about contracts and construction—they are about people. And people support what they understand and believe in.

As a brand and communication expert, I firmly believe that communication is the invisible infrastructure behind every successful public-private partnership. Let's build it with the same care and commitment we bring to roads, hospitals and energy grids.

Simplifying Forex Payments to Transaction Advisors: A Boost for PPP Project Delivery

In a significant move to facilitate the implementation of approved Public-Private (PPP) Partnership projects, Bangladesh Bank has issued a new directive Foreign Exchange Circular No. 22, dated June 18, 2025-aimed at easing the remittance process consultancy and service fees in foreign currency. This circular is expected to bring major relief to PPP stakeholders international investors streamlining the approval process for sending payments abroad, particularly for the Transaction Advisors (TAs).

The circular grants general authorization to designated **Authorized** Dealer (AD) banks to remit various current account service fees-including consultancy and management fees-without requiring case-by-case approval from Bangladesh This Bank. initiative addresses long-standing concerns of foreign investors, reducing procedural delays and boosting the attractiveness of PPP projects in Bangladesh.

Streamlined Fund Flow for Project-Related Services

As per the circular issued by the Foreign Exchange Policy Department, AD banks may now remit legitimate current account service fees—such as consultancy, management and other

operating fees—without prior approval from the central bank, provided specific conditions are met. This is a welcome reform for PPP stakeholders, as delays in remitting project-related expenses have historically deterred foreign participation in large infrastructure projects.

Given the essential role of international consultants, technology specialists and management experts in ensuring the quality and timely delivery of PPP

projects, this easing of foreign remittance regulations is particularly significant.

Among the conditions outlined in the circular:

 The project must be duly approved by competent government authorities.

- Valid service contracts with foreign beneficiaries must be in place.
- Documentation such as VAT and withholding tax certificates, along with a certificate from the Implementing Agency confirming receipt of services, must be submitted—ensuring transparency and compliance with international norms.

Boosting Investor Confidence

Foreign investors in PPP projects often face difficulties with currency

conversion and fund repatriation. This circular directly addresses these issues by creating transparent a streamlined framework for remitting operational costs abroad. enhanced clarity and predictability will significantly strengthen the confidence of both investors and Transaction Advisors, enabling them to meet their international financial commitments without bureaucratic delays.

This step complements the ongoing efforts of the PPP Authority of Bangladesh to create a more investor-friendly environment and will reinforce investor trust by reducing administrative burdens and project implementation risks.

Clear Procedures and Defined Oversight

Under the new guidelines, AD branches nominated by the project authorities will manage the remittance process and notify Bangladesh Bank prior executing the transactions. This decentralized approach both simplifies the remittance process and retains an appropriate level regulatory of oversight, ensuring a balanced system of facilitation and control.

Additionally, the circular reaffirms the requirement to follow Bangladesh

Investment Development Authority (BIDA) guidelines for remittances related to royalty, technical know-how, and franchise fees. Thus, while the remittance process for service-related fees is simplified, specialized transactions will still follow established regulatory protocols.

Importantly, compliance with Know Your (KYC), Customer Anti-Money Laundering (AML) and Combating the Financing of Terrorism (CFT) standards remains mandatory, upholding the integrity of the financial system. Bangladesh Bank's forward-thinking circular represents a significant policy shift in support of PPP growth. By simplifying the foreign remittance process for service-related project expenses, it not only enhances the efficiency of operational projects but also sends a strong, positive message to the global investment community. This move marks impotent step toward unlocking the full potential of public-private partnerships Bangladesh's infrastructure development economic and advancement.
