



Besides, JV sub-consultant partner may be associated, but sub-consultant/s experience will not be taken into consideration. 2. In case of the consortium, legal documents (as a form of JV agreement as per PPR 2008 and PPA 2006) on the partners' roles and responsibilities should be included as an attachment to the EoI proposal. One member of the consortium represents as prime partner (Lead Member) and other as a member partner. 3. A letter of association will be needed for any member, represent as a subconsultant. 4.
