(E) The firm shall have office in Dhaka, Bangladesh during the performance of the assignment. If any international firm intends to submit EOI, it must have office in Dhaka or shall commit to establish office in Dhaka during the assignement if the firm is awarded the contract. Oterwise, it can form JV with local or other international firm which has office in Dhaka, Bangladesh.
